1. Introduction

This sixth Annual Report on Subsidiarity sets out the subsidiarity and proportionality-related activities of the Committee of the Regions (CoR) in 2015. The CoR adopted and implemented its third Subsidiarity Work Programme $(SWP)^1$ on the basis of the Work Programme of the European Commission.

The European Commission made subsidiarity and proportionality its priorities and gave the responsibility to ensure the respect for these principles to its First Vice-President. Therefore, the European Commission's 2015 Work Programme², with 23 new initiatives, had a specific focus on subsidiarity and proportionality. Moreover, the work programme applied the principles of political discontinuity and better regulation to reduce "EU interference on the issues where Member States are better equipped to give the right response at national and regional level"³. The First Vice-President, Mr Timmermans, speaking at the 7th Subsidiarity Conference⁴, emphasised in this context that the Commission needed expertise and input from the Committee of the Regions (CoR).

The sixth Annual Report on Subsidiarity has two main aims: to outline the Committee of the Regions' subsidiarity monitoring activities during the year and their impact, and to give an overview of other important subsidiarity-related activities. The report presents the main features of the Subsidiarity Work Programme 2015, followed by a summary of activities carried out with a view to its implementation in 2015 (part 2). The governance structure and tools for subsidiarity monitoring are described (part 3) and the impact of the monitoring is then assessed by examining the content of relevant CoR opinions with regard to subsidiarity (part 4). Part 5 is devoted to the most important events of the year and activities in the field of subsidiarity. Finally, conclusions are drawn and the outlook for the following year is presented (part 6).

2. Subsidiarity Work Programme 2015

2.1 Adoption

In accordance with the Subsidiarity Monitoring Strategy⁵, a Subsidiarity Work Programme for 2015 was drawn up using a procedure comprising several steps. The first step consisted of an initial preselection of legislative initiatives from the European Commission Work Programme 2015 by the Subsidiarity Expert Group based on the criteria set out below and information available at that stage. For the first time, representatives of national parliaments have been engaged in an exchange of views on the priority-setting for the Subsidiarity Work Programme in a session alongside the Subsidiarity Expert Group⁶.

The following selection criteria were applied:

- a) initiatives should present a clear political interest for local and regional authorities;
- b) initiatives should touch on competences of local and regional authorities;
- c) initiatives should bear a potential subsidiarity dimension.

The second step entailed the presentation of the draft Work Programme at the CIVEX commission meeting on 24 February and endorsement by the Subsidiarity Steering Group by written procedure on 16 March 2015. The final programme was adopted by the CoR Bureau on 15 April 2015.

The Subsidiarity Work Programme also included the tools available to the CoR for subsidiarity monitoring, to be activated throughout the year in the light of the institutional calendar and the actual content of proposals (Appendix 1).

2.2 Implementation

On the basis of the Subsidiarity Work Programme, the CoR administration set up an internal early flagging system to ensure the proper monitoring of the selected EU initiatives that might raise subsidiarity concerns. The implementation of the SWP requires the involvement at the earliest possible stage of all relevant political and administrative stakeholders, with a view to identifying and planning subsidiarity monitoring activities. In 2015, one initiative described in the following point was thus monitored with the help of the tools available. As several initiatives in the Commission's Work Programme were published as non-legislative ones, they could not be monitored as initially planned⁷.

2.2.1 Decision-making process on genetically modified food and feed

In its opinion "**Decision-making process on genetically modified food and feed**⁸" (rapporteur Marc Weinmeister, DE/EPP), the CoR considered that "*a prohibition option entails unreasonably high hurdles for a Member State to overcome before it can exercise this option at national level and impose a ban; this raises subsidiarity concerns and indicates that the proportionality principle would clearly be breached under this proposal*".

The underlying Proposal for a Regulation as regards the possibility for the Member States to restrict or prohibit the use of genetically modified food and feed on their territory⁹ had been submitted to a consultation of the Subsidiarity Expert Group¹⁰. The experts concluded that the draft regulation complied with the principles of subsidiarity and proportionality, but some of them raised the question of whether the draft Regulation really enables Member States to lawfully impose national bans and restrictive measures concerning genetically modified food and feed. This concern has been echoed in the CoR opinion.

2.2.2 Better Regulation Agenda

The Better Regulation package¹¹ was an initiative to be followed with special focus. The input provided by a discussion held during the 6th meeting of the Subsidiarity Expert Group on 29th June 2015 was sent to the rapporteur, Spyros Spyridon (EL/EPP). The Subsidiarity Expert Group broadly welcomed the package, not least because several demands of the CoR put forward in the past have been taken into account and the Commission has committed to providing more thorough justifications concerning compliance of legislative initiatives with the principles of subsidiarity and proportionality. However, the experts considered that Commission proposals should better take account of the local and regional level of governance. The CoR opinion on the framework communication "Better regulation for better results - An EU agenda"¹² reflected these concerns and called on the Commission and the co-legislators to consult the CoR and local and regional authorities more closely when carrying out impact assessments throughout the policy lifecycle. Moreover, the CoR welcomed the extension of consultations to include local and regional authorities, stakeholders and citizens in the preliminary legislative stages and in the implementation of legislation.

2.2.3 Initiatives not submitted to subsidiarity monitoring

The following initiatives included in the SWP were dealt with by non-legislative Commission acts, and in consequence were not submitted to subsidiarity monitoring:

- Strategic Framework for the Energy Union
- Labour Mobility Package
- European Agenda on Migration

One more initiative from the Subsidiarity Work Programme 2015 - the legislative proposals of the Circular Economy Package replacing the withdrawn proposal on the review of EU waste targets from 2014^{13} - was not monitored in 2015, as the proposals were presented in December 2015. The proposals were thus included into the Subsidiarity Work Programme 2016.

3. Political governance and CoR tools for subsidiarity monitoring

3.1 Subsidiarity Steering Group

The Subsidiarity Steering Group was set up in September 2012 in order to provide political governance for subsidiarity monitoring at the CoR and to ensure coordination between the administrative and political activities of the CoR on subsidiarity matters. During the reference year, the Subsidiarity Steering Group further consolidated the subsidiarity monitoring activities and adapted them to the reorganisation of the CoR Secretariat General, in order to use all synergies resulting from the attachment of subsidiarity monitoring activities to the CIVEX commission, at political and administrative level. In this framework, the Steering Group adopted an internal working document laying down such an adapted governance structure.

Furthermore, the Subsidiarity Steering Group also played an important role at the 7th Subsidiarity Conference on 17 November 2015¹⁴. Each Steering Group member had a specific role of "first respondent" giving impetus to the discussion. Moreover, the chair of the Subsidiarity Steering Group moderated the High-level panel and the closing session of the Conference.

Attention should also be drawn to the key role played by Steering Group members in raising awareness of subsidiarity and proportionality monitoring and helping the CoR to establish contacts with national and regional parliaments.

The activities of the Steering Group in 2015 helped to ensure that subsidiarity matters had a high profile in the CoR's political activities.

3.2 Subsidiarity Expert Group

Under the revised subsidiarity strategy, the Subsidiarity Expert Group was set up to provide back-up for subsidiarity monitoring with expert knowledge from the local and regional level. The members of the group were selected for their expertise and experience in subsidiarity monitoring from among the members of the Subsidiarity Monitoring Network.

The Subsidiarity Expert Group made one of its most important contributions at the beginning of the subsidiarity monitoring cycle, during the preparation of the CoR Subsidiarity Work Programme. At the beginning of 2015, the experts assisted the CoR in the selection of subsidiarity priorities from the European Commission's Work Programme 2015. The involvement of the experts ensures that initiatives that are particularly relevant from the point of view of subsidiarity and of interest to regional and local authorities are selected to form part of the CoR Subsidiarity Work Programme in order to be subject to thorough subsidiarity monitoring.

As already mentioned above (points 2.2.1 and 2.2.2), the Subsidiarity Expert Group dealt intensively with two dossiers of the Subsidiarity Work Programme 2015, and the outcome has been forwarded to the relevant rapporteur. Furthermore, members of the Expert Group actively contributed to the discussion on subsidiarity and proportionality during the 7th Subsidiarity Conference.

The experts' contribution to the CoR's consultative activities creates a link to the subsidiarity debate in Member States, strengthens mutual comprehension and brings the CoR closer to its local and regional partners and thus to the needs of Europeans. In fact, the Expert Group also serves as a network of "core" CoR contact points for subsidiarity in Member States. Consequently, the active participation of the SEG helps create a culture of subsidiarity in Europe.

3.3 Subsidiarity Monitoring Network

Through the Subsidiarity Monitoring Network¹⁵ launched in 2007, the CoR enables its partners to become involved in various phases of the EU decision-making process. This is an important function in view of the Lisbon Treaty, which underlines the local and regional dimension of subsidiarity and strengthens the CoR's role with regard to subsidiarity monitoring. The network grew further in 2015 and included 150 partners at the end of the year¹⁶. The newcomer in 2015 was the Mecklenburg-Vorpommern State Parliament (Germany), a regional assembly with legislative powers. The Network now includes local and regional authorities and their associations, regional parliaments as well as a few national parliaments and national CoR delegations. Efforts will be continued to encourage the active participation of all network partners in consultations and subsidiarity-related activities and to further extend the network, so as to gain EU-wide representation.

4. Subsidiarity in CoR opinions

Pursuant to Rule 55(2) of the Rules of Procedure¹⁷, the CoR assesses in its opinions compliance of legislative proposals based on shared competences with the subsidiarity and proportionality principles.

The CoR adopted 46 opinions in 2015¹⁸. Out of these 46 opinions, six referred to a legislative proposal and five included an assessment of compliance with the subsidiarity principle. One of them, the opinion on the **Decision-making process on genetically modified food** and feed was part of the Subsidiarity Work Programme 2015 (see chapter 2.2.1). The opinion "**Towards a circular economy: review of EU waste legislation**"¹⁹ concerned the previous legislative proposal in this context²⁰, which had finally been withdrawn by the European Commission, and was adopted by the CoR in February 2015. It did not identify subsidiarity problems, but highlighted proportionality issues "with regard to the varying levels of implementation of the current targets and the timetable for the new targets envisaged by the Commission". It thus reflected the outcome of the consultation of the Subsidiarity Monitoring Network and the Subsidiarity Expert Group in 2014 on the legislative proposal at stake²¹.

The opinion on "Interoperability as a Means for Modernising the Public Sector"²² concluded that the underlying legislative proposal²³ complied with the principles of subsidiarity and proportionality, but called for effective involvement of local and regional authorities during the implementation of the programme on interoperability solutions and common frameworks for European public administrations, businesses and citizens (ISA²).

In the opinion²⁴ on the "**Investment plan and European Fund for Strategic Investments**"²⁵ the CoR found that "the main objective is to contribute to a relaunch of investments at European level with clear transnational aspects" and thus concluded on compliance with the subsidiarity principle. Moreover, it considered the draft regulation as an appropriate legal instrument which respects the proportionality principle.

In the opinion²⁶ on the **Tax Transparency Package**²⁷ the CoR was convinced by the arguments presented in the explanatory memorandum of the legislative proposal on the added value of legislating at European Union level, and concluded on compliance with the principles of subsidiarity and proportionality.

The opinion²⁸ on the Proposal for a Council Decision on "**Guidelines for the employment policies of the Member States**"²⁹ did not contain an assessment of compliance with the principles of subsidiarity and proportionality, but a general reference to subsidiarity. The opinion acknowledged that the guidelines, addressed to Member States, should be implemented in partnership with the local and regional authorities "*which, considering their competences and capacities in the fields covered by these guidelines and according to the principle of subsidiarity, are essential for designing and implementing National Reform Programmes"*. The draft Council Decision is a legislative proposal with a specific character insofar as it does not contain concrete legislative measures which could be submitted to a subsidiarity monitoring, but guidelines with common priorities and targets supposed to guide national employment policies and reform programmes. However, there were no apparent subsidiarity appears to be sufficient, even if formally the opinion did not comply with Rule 55(2) of the Rules of Procedure.

Forty opinions were adopted on non-legislative initiatives; out of these twenty-one include a reference to subsidiarity and eight a reference to proportionality although it is not a mandatory requirement under the Rules of Procedure.

There was no need for the Subsidiarity Steering Group to intervene and table amendments in view of compliance with Rule 55(2). This is an important step forward and confirms that the quality of subsidiarity references in CoR opinions has improved.

In terms of support for the assessment of compliance with the subsidiarity and proportionality principles at administrative level, the Subsidiarity team contributed in seven cases to policy analyses for rapporteurs at the request of thematic commission secretariats. This helped to inform rapporteurs early in the drafting process about the requirements of the Rules of Procedures and the content and form of the compliance assessment.

5. Subsidiarity-related events and activities

A major event in the area of subsidiarity was the 7th **Inter-Institutional Subsidiarity Conference**, jointly organised by the CoR and the Flemish Parliament, which took place on 17 November 2015 at the Flemish Parliament in Brussels. It gathered over 200 participants from different national and EU

institutions and representing all relevant levels of governance. Six months on from the publication of the Commission's Better Regulation package, the conference also provided an opportunity to discuss how to make its proposals a practical reality. The conference brought together key institutional players, and among the speakers were the First Vice-President of the European Commission Frans Timmermans, Minister Nicolas Schmit representing the Luxembourg Presidency of the Council of the EU, and the Chair of the European Parliament's Legal Affairs Committee, Pavel Svoboda. The debate made it clear that Better Regulation and its application in practice were a matter of primary concern not only for the EU institutions and Member States, but also for local and regional authorities who brought unique added value to EU policy development and to the legislative process. It was also concluded that in order to have better regulation, the principles of subsidiarity and proportionality must be correctly applied. Moreover, the conference triggered an exchange of practical experiences between players from different levels of governance and provided an opportunity to build a bridge between the activities of the Luxembourg Presidency and the vision of the incoming Dutch Presidency³⁰.

With a view to fostering the subsidiarity culture and information exchange with partner organisations, the CoR stepped up its relationship with the Conference of European Regions Legislative Assemblies (CALRE) by signing a Memorandum of Understanding³¹ on 9 July 2015. The CoR participated in the meeting of the Subsidiarity Working Group of CALRE on 10 July and exchanged with CALRE members on subsidiarity-relevant dossiers of the work programme.

Regarding relations with regional parliaments, the CoR developed a pilot project of awareness-raising activities (information and training sessions open to regional parliaments and governments, politicians and administrative staff) in order to explain the principle of subsidiarity, the (political) importance of subsidiarity monitoring and the role of the CoR in this framework. Cooperation with the Italian Conference of Regional Parliaments and Italian Senate was established and the first event in this framework was organised for the beginning of 2016.

6. Conclusion and outlook

In 2015, subsidiarity monitoring at the CoR was further consolidated by the implementation of the third Subsidiarity Work Programme. The monitoring tools at hand, such as the Subsidiarity Monitoring Network, the Subsidiarity Expert Group and REGPEX, have enabled the CoR to successfully carry out this task. The Subsidiarity Steering Group further consolidated the subsidiarity monitoring activities and adapted them to the reorganisation of the CoR Secretariat General, in order to be able to use all synergies resulting from the attachment of subsidiarity monitoring to the CIVEX commission, at political and administrative level.

The CoR is strongly committed to its specific responsibilities with regard to subsidiarity monitoring resulting from the Lisbon Treaty and therefore continues its efforts to ensure the effective application of the subsidiarity principle and to contribute to the creation of a subsidiarity culture within the EU.

The CoR notes with satisfaction that subsidiarity monitoring is becoming increasingly important in the inter-institutional debate and that the European Commission places particular emphasis on subsidiarity. However, the CoR considers that it is necessary to further highlight the importance of subsidiarity monitoring and to exchange information and experiences with national and regional parliaments in this context.
