#### 1. **Introduction**

This ninth Annual Report on Subsidiarity sets out the subsidiarity and proportionality-related activities of the European Committee of the Regions (CoR) in 2018. In that year, in line with the Treaty on the EU (Art. 5(3)), which explicitly contains a local and regional dimension and thus underlines the need to respect the competences of local and regional authorities within the EU, the CoR monitored application of the subsidiarity principle through its various instruments. In the Subsidiarity Work Programme, five priority initiatives and five additional initiatives were originally selected from the European Commission's 2018 Work Programme. However, due to the work of the CoR delegation to the Task Force on Subsidiarity, Proportionality and Doing Less More Efficiently<sup>1</sup>, the subsidiarity monitoring activities of the CoR were suspended for the first half of 2018. As part of the revised Subsidiarity Work Programme for the second half of 2018<sup>2</sup>, two priority initiatives out of the originally selected five were monitored with particular attention to one additional initiative. In addition, using its own internal rules<sup>3</sup>, the CoR assessed the compliance with the subsidiarity and proportionality principles of legislative proposals on which it issued opinions.

In order to achieve the best possible legislation, the CoR seeks to constructively contribute to the European decision-making process at an early stage; the purpose of its subsidiarity monitoring activities in 2018 was to detect any subsidiarity and proportionality concerns as early as possible in the legislative procedure.

The ninth Annual Report on Subsidiarity presents the main features of the Subsidiarity Work Programme 2018, summarises activities carried out with a view to its implementation in 2018 and details the governance structure and tools for subsidiarity monitoring as well as the impact of the monitoring through an examination of the content of relevant CoR opinions with regard to subsidiarity. The final sections are devoted to the most important events of the year in the field of subsidiarity, as well as the conclusions and outlook for the following year.

## 2. Subsidiarity Work Programme 2018

## 2.1 **Adoption**

In accordance with the Subsidiarity Monitoring Strategy<sup>4</sup>, a Subsidiarity Work Programme for 2018 was drawn up using a procedure comprising several steps. The first step consisted of an initial pre-selection of legislative initiatives from the European Commission Work Programme 2018 by the Subsidiarity Expert Group<sup>5</sup> and the CoR commission chairs, based on the following criteria and information available at that stage:

- a) initiatives should present a clear political interest for local and regional authorities;
- b) initiatives should touch on competences of local and regional authorities;
- c) initiatives should bear a potential subsidiarity dimension;
- d) preference should be given to legislative proposals; moreover, this selection takes account of CoR priorities and initiatives included in the work programmes of the thematic commissions.

The second step entailed endorsement by the Subsidiarity Steering Group (SSG) by written procedure on 20 November 2017 and the presentation of the draft Work Programme at the CIVEX Commission meeting on 23 November 2017. Due to the work of the CoR delegation to the Task Force on Subsidiarity, Proportionality and Doing Less More Efficiently, the subsidiarity monitoring activities of the CoR were suspended for the first half of 2018 and a revised Subsidiarity Work Programme for the second half of 2018 was adopted by the Subsidiarity Steering Group on 17 May 2018. The programme for the second half of 2018 was adopted as the final programme by the CoR Bureau on 3 July 2018.

## 2.2 **Implementation**

On the basis of the Subsidiarity Work Programme (SWP), the CoR administration set up an early internal flagging system to ensure proper monitoring of the selected EU initiatives that might raise subsidiarity concerns. The implementation of the SWP requires the involvement at the earliest possible stage of all relevant political and administrative stakeholders, with a view to identifying and planning subsidiarity monitoring activities. Below are the priority and additional initiatives included in the Subsidiarity Work Programme for the second half of 2018, as adopted by the CoR Bureau:

## 2.2.1 Social fairness package

In the framework of this package of proposals, from a subsidiarity and proportionality monitoring perspective, the Subsidiarity Steering Group highlighted that focus should be placed on the legislative initiatives relating to establishing a European Labour Authority, published on 13 March 2018. The Subsidiarity Expert Group (SEG) was consulted regarding the legislative proposal on establishing a European Labour Authority<sup>6</sup>. The majority of experts raised concerns regarding the application of subsidiarity, but did not see this proposal as an outright breach of the principle. The main question pointed out by both of these contributions is whether the new "European Labour Authority" is indeed a better alternative, in the sense of scale and effect, to a reinforced cooperation mechanism between national authorities. The opinion<sup>7</sup> concluded that: "the subsidiarity principle has to be complied with fully at every development level of the ELA and all national competences in labour and social policy matters respected", noting that the European Labour Authority has to allow for the different labour market models and priorities that Member States may have.

### 2.2.2 Multi-annual Financial Framework

The Multi-annual Financial Framework<sup>8</sup> was the second priority initiative in 2018. Out of the package of legislative proposals, the *Proposal for a Council decision on the system of Own Resources of the European Union* (COM (2018) 325) has garnered the most attention, with no concerns stated regarding the proposal. The only proposal where concerns were raised was the *Proposal for a Regulation of the European Parliament and of the Council on the protection of the Union's budget in case of generalised deficiencies as regards the rule of law in the Member States* (COM(2018) 324), where it was highlighted that there was no impact assessment and that, due to its importance and completely new content, this should be regarded as a fundamental procedural deficiency. The opinion<sup>9</sup> included that the CoR "finds it regrettable that the Commission proposal to introduce new own resources does not provide a sufficient assessment of compliance with the subsidiarity principle and the proposal's potential impact on the financial situation of local and regional authorities has not been evaluated".

### 2.2.3 Additional initiatives

Only one additional initiative was included in the Subsidiarity Work Programme for the second half of 2018 – *Fair taxation in the digital economy*. No consultations were carried out for the additional initiative.

The priority initiatives included in the original Subsidiarity Work Programme for 2018 were: Implementation of the Action Plan on Circular Economy, EU Civil Protection Mechanism and Completing the Economic and Monetary Union, while the additional initiatives not included in the Subsidiarity Work Programme for the second half of 2018 were Doing less more efficiently, Follow up to Environmental Monitoring & Reporting Fitness Check (EMR), EU food supply chain and Delivering on the EU Agenda on Migration.

## 3. Political governance and CoR tools for subsidiarity monitoring

## 3.1 **Subsidiarity Steering Group**

The Subsidiarity Steering Group was set up in September 2012 to provide political governance for subsidiarity monitoring at the CoR and to ensure coordination between the CoR's administrative and political activities on subsidiarity matters. During 2018, the Subsidiarity Steering Group continued to direct subsidiarity monitoring activities, adapting them to facilitate the work of the CoR delegation to the Task Force on Subsidiarity, Proportionality and Doing Less More Efficiently. In this regard, the number of Subsidiarity Steering Group meetings in 2018 has increased significantly in comparison to 2017, with five meetings being held in total.

Throughout 2018, a number of important decisions have been made by the Subsidiarity Steering Group (SSG):

- Notably, the SSG has decided on the Subsidiarity Work Programme for 2019, which includes three priority initiatives selected by the Subsidiarity Expert Group.
- As the bi-annual CoR Subsidiarity Conference is taking place in 2019, the SSG has made their selection of the host of the event. Out of the three official applications to host the event including the Italian Conference of Presidents of the Regional Parliaments (Italy), Harghita County (Romania) and the Mazovia Region (Poland) the SSG has selected the Italian Conference of Presidents of the Regional Parliaments. The CoR has already cooperated with the Italian Conference of Presidents of the Regional Parliaments in an awareness-raising and training event in 2016.
- Lastly, the Subsidiarity Steering Group has taken up the governance of the pilot project for a
  network of regional hubs. The project is a direct effort of the CoR to implement the
  recommendations of the Task Force and aims at gathering and using regional and local data
  on policy implementation. The pilot phase is foreseen to include 20 European regions and is
  envisaged to run for two years.

A change in membership of the Subsidiarity Steering Group was also noted in 2018, with Kieran McCarthy (IE/EA) replacing Mairi Angela Gougeon (UK/EA) as the European Alliance representative within the group.

## 3.2 **Subsidiarity Expert Group**

Under the revised subsidiarity strategy, the Subsidiarity Expert Group was set up to provide back-up for subsidiarity monitoring with expert knowledge from the local and regional level. The members of the group were selected from members of the Subsidiarity Monitoring Network for their expertise and experience in subsidiarity monitoring.

The preparation of the CoR Subsidiarity Work Programme, one of the Subsidiarity Expert Group's most important contributions, is carried out at the beginning of the subsidiarity monitoring cycle. In late 2018, the experts assisted the CoR with the selection of subsidiarity priorities from the European Commission's Work Programme for 2019. The involvement of the experts ensures that initiatives that are particularly relevant from the point of view of subsidiarity and of interest to regional and local authorities are selected to form part of the CoR Subsidiarity Work Programme in order to be subject to thorough subsidiarity monitoring.

Apart from selecting the priority initiatives for 2019, the Subsidiarity Expert Group, as mentioned above, has contributed significantly to the analysis of the two priority initiatives included in the Subsidiarity Work Programme for the second half of 2018. Members of the Expert Group also actively contributed to the work of the Task Force on Subsidiarity, Proportionality and Doing Less More Effectively. The experts were consulted on Task (a) of the Task Force mandate 10, notably on the Subsidiarity Assessment Grid, and the results were included in the CoR members' contribution to the third meeting of the Task Force on 15 March 2018.

The experts' contribution to the CoR's consultative activities creates a link to the subsidiarity debate in Member States, strengthens mutual understanding and brings the CoR closer to its local and regional partners and thus to the needs of Europeans. In fact, the Expert Group also serves as a network of "core" CoR contact points for subsidiarity in Member States. Consequently, the active participation of the SEG helps create a culture of subsidiarity in Europe.

#### 3.3 **Subsidiarity Monitoring Network**

Through the Subsidiarity Monitoring Network<sup>11</sup> launched in 2007, the CoR enables its partners to become involved in various phases of the EU decision-making process. This is an important function in view of the Lisbon Treaty, which underlines the local and regional dimension of subsidiarity and strengthens the CoR's role with regard to subsidiarity monitoring. The network saw only slight changes in its composition in comparison to 2017, with the number of partners increasing from 155 to 156 by the end of the year<sup>12</sup>. The sole newcomer in 2018 was the Maia municipality government from Portugal. The CoR will maintain its efforts to encourage both new applications to extend the network, as well as active participation from current network partners in consultations and subsidiarity-related activities.

In 2018, the REGPEX<sup>13</sup> platform has seen further growth in activity. The sub-network of the Subsidiarity Monitoring Network open to parliaments and governments of regions with legislative powers has steadily been increasing in usage, with 95 unique contributions 14 made throughout the year. In comparison to the previous years (66 contributions in 2017, 28 contributions in 2016), this is a very significant and welcome incline. The REGPEX search engine facilitates a selection of priorities for subsidiarity monitoring and an exchange of information between partners by providing direct access to information for subsidiarity analysis, and links to EurLex, IPEX, CoR opinions and other REGPEX partners' contributions. The search engine has seen an update towards the end of 2018, improving the accessibility and functionality for external and internal users alike. As REGPEX continues to be an important instrument for subsidiarity monitoring in the CoR, development of the platform will continue in 2019. It plays a vital role in the monitoring of initiatives under the Early Warning System and fosters the exchange of good practice and a more common approach to subsidiarity monitoring.

The most active partners of the REGPEX platform in 2018 were the Emilia Romagna Regional Legislative Assembly with 21 unique contributions, followed by the Bavarian State Parliament with 20 and the Thüringen State Parliament with 18 unique contributions respectively. This is mostly in line with previous years. The Commission documents that have garnered the most contributions were the Proposal for a Directive of the European Parliament and of the Council on the quality of water intended for human consumption (recast)<sup>15</sup> and the Proposal for a Decision of the European Parliament and of

the Council amending Decision No 1313/2013/EU on a Union Civil Protection Mechanism<sup>16</sup>, both with six contributions from unique partners.

## 4. Subsidiarity in CoR opinions

Pursuant to Rule 55(2) of the Rules of Procedure<sup>17</sup>, the CoR assesses in its opinions the compliance of legislative proposals on shared competences with the subsidiarity and proportionality principles.

The CoR adopted 78 opinions in 2018<sup>18</sup>. Out of these 78 opinions, 40 referred to a legislative proposal; 35 included an assessment of compliance with the subsidiarity principle; and 33 included an assessment of compliance with the proportionality principle. In terms of support for the assessment of compliance with the subsidiarity and proportionality principles at administrative level, the subsidiarity team contributed in five cases to policy analyses for rapporteurs at the request of thematic commission secretariats and has carried out two analyses for opinions submitted to the CoR's plenary sessions.

## 5. Subsidiarity-related events and activities

2018 was marked by a widespread debate on subsidiarity and proportionality, which started with the formation of the Task Force on Subsidiarity, Proportionality and Doing Less More Efficiently by European Commission President Juncker. The work of the Task Force has been a major development in the way that the principles of subsidiarity and proportionality are regarded within the European Union. The CoR delegation to the Task Force, consisting of President Karl-Heinz Lambertz, Dr Michael Schneider and François Decoster, had the clear objective of improving the involvement of local and regional authorities in the European decision-making process. A number of proposals made by the CoR have been taken up and included in the Task Force final report.

- A clear recognition of the need to significantly increase the involvement of local and regional authorities in a structured way in all phases of the EU decision-making process, to enhance the added value of EU legislation for our citizens described by the European Commission's first Vice-President Timmermans as "a new way of working";
- An "Active Subsidiarity" approach that gives all relevant actors an opportunity not only to highlight possible infringements of the subsidiarity and proportionality principles, but also to provide positive contributions to the development of EU legislation and to ensure that it meets the minimum subsidiarity and proportionality criteria of added value;
- The development and use of a common Subsidiarity Assessment Grid by all levels of governance and EU institutions in order to facilitate a more effective and comparable approach to the subsidiarity scrutiny procedure;
- A systematic Territorial Impact Assessment by the European Commission when local and

regional authorities are likely to be impacted significantly by the proposed legislation;

The establishment of a structured EU mechanism to evaluate existing and proposed legislative acts from the point of view of subsidiarity, proportionality, legislative density and the involvement of local and regional authorities;

The CoR has also supported the work of the Task Force by hosting a hearing in May 2018 where relevant stakeholders had a chance to voice their concerns and suggestions directly to the Task Force members and by carrying out a broad consultation of more than 2 500 regional and local stakeholders<sup>19</sup>.

Following the end of the Task Force mandate with the presentation of the Final Report of the Task Force<sup>20</sup> to President Juncker on 10 July 2018, the CoR has maintained its efforts to promote the recommendations of the Task Force. At the 14 September 2018 Bureau meeting, the CoR expressed its commitment to the values, principles and recommendations put forward by the Task Force<sup>21</sup>. At the 8 October 2018 Bureau meeting the CoR made its first concrete step in implementing the recommendations of the Task Force by launching the pilot project for a network of regional hubs on the implementation of EU legislation<sup>22</sup>. At the 4 December 2018 Bureau meeting a note on *Developing* Active Subsidiarity in the political work of the CoR<sup>23</sup> was put forward for discussion.

Apart from internal subsidiarity-related activities, the CoR has participated in the Subsidiarity Conference of the Austrian Presidency<sup>24</sup>, held in Bregenz on 15-16 November 2018 and has hosted a CALRE<sup>25</sup> working group on subsidiarity on 6 September 2018.

#### 6. Conclusion and outlook

The CoR is strongly committed to its responsibilities with regard to subsidiarity monitoring resulting from the Lisbon Treaty and therefore is continuing its efforts to ensure effective application of the subsidiarity principle and to contribute to the creation of a subsidiarity culture within the European Union. It is also committed to the implementation of the recommendations of the Task Force on Subsidiarity, Proportionality and Doing Less More Efficiently, which promote an inclusive and constructive approach to subsidiarity and proportionality monitoring within the European Union and highlight the importance of local and regional levels in the EU policymaking process.

In that regard, the CoR aims to keep up its efforts to promote the implementation of these principles and

recommendations in 2019, with the 8<sup>th</sup> European Summit of Regions and Cities<sup>26</sup>, held on 14-15 March 2019 in Bucharest, as the first opportunity to further develop the debate on subsidiarity and proportionality. The bi-annual Subsidiarity Conference of the CoR will take place in Rome on 22 November 2019 and will be an important event in ensuring that the work of the Task Force feeds into the next European Parliament mandate and the new European Commission college. Apart from these outstanding events, the CoR and the Subsidiarity Steering Group will continue to reflect on ways to raise awareness, improve working methods and increase the added value of the existing subsidiarity monitoring framework of the CoR.

As the active subsidiarity approach calls for involvement from all relevant actors within the EU decision-making process, the CoR will maintain its efforts to promote a partnership approach, in line with the principle of multi-level governance, between all institutional, national and sub-national actors.
